Principles for using support "Consultations concerning the second specialised subject

for doctoral candidates participating in IDSMM"

realised within the project "PWP Interdisciplinary Doctoral Studies in Mathematical Modelling"

§ 1 General Information

- 1. The project "PWP Interdisciplinary Doctoral Studies in Mathematical Modelling", hereinafter referred to as "the Project" is realised by the University of Gdańsk and co-financed by the European Union within the European Social Fund Human Capital Operational Programme, Priority 4 Higher Education and Science, Measure 4.1 Strengthening and developing the didactic potential of the University and increasing the number of graduates in specialisations with key importance for knowledge-based economy, Sub-measure 4.1.1 Strengthening the didactic potential of the University.
- 2. The Project is realised from 1st January 2014 to 30th June 2015.
- 3. The Project Office is located at the Dean's Office, Faculty of Mathematics, Physics and Informatics of the University of Gdańsk.
- 4. "Consultations concerning the second specialised subject for doctoral candidates participating in IDSMM", hereinafter referred to as the "Consultations", are individual consultations between a doctoral candidate and a chosen mentor. The mentor shall be chosen by the doctoral candidate in close consultation with the promoter of his/her research. The mentor has to be informed about it and give his/her preliminary consent.

§ 2 Participation in Consultations

- 1. Doctoral candidates taking part in the IDSMM studies are the only persons who realised at the University of Gdańsk, Faculty of Mathematics, Physics and Informatics, in the academic year 2014/2015, are the only persons who may participate in the Consultations.
- 2. Each of the IDSMM doctoral candidates may use the maximum of 9 consultation hours, from the 1st January to the 31st May 2015.
- The participants who want to take advantage of the Consultations are obliged to fill in and sign the DECLARATION ON USING SUPPORT (Appendix No. 1), which is also available on the website http://mat.ug.edu.pl/idsmm. The mentor shall be indicated when the declaration is filed at the Project Office.
- 4. In the situation where some of the doctoral candidates fail to use their maximum allowance of Consultation hours, the Project Manager shall be entitled to allocate, to the doctoral candidates who have already used up their limit, additional Consultation hours in June. The aggregate number of Consultation hours shall not exceed 90 hours. The Head of the IDSMM studies shall have a decisive say in selection of the candidates to whom the additional hours are to be allocated.
